Biophilia is one of the main drivers for environmental policy, building design, community cohesion, health, and therapeutic approaches. It is used to gird environmental policy, retail design, school and hospital design, open space planning and community planning. Popularized by E.O. Wilson but coined by Eric Frohmm, biophilia means "love of life" and explains our love for pets, water, gardening, flowers, and outdoor recreation. It can be used effectively as a policy lever as we address housing, tree retention, climate resilience, therapy for trauma and design for learning and nurturing, all cornerstones of a functioning society.
