WSC 6PPD-q: A new 2-page informational flier aims to raise awareness and shed light on the current research findings around the common rubber preservative 6PPD-quinone. Developed by Washington Stormwater Center researchers in collaboration with Washington State University, The University of Washington, and The Center for Urban Waters, this resource graphically illustrates what the compound is, what habitats are most at risk, and what we can do to curtail its impacts on our ecosystems.

Clean Water Act Financial Capability Assessment Tool Webinar Nov. 29, 2023 3PM ET The U.S. Environmental Protection Agency (EPA) is hosting a webinar to provide an overview of EPA's Financial Capability Assessment (FCA) Spreadsheet Tool to support use of the 2023 Clean Water Act (CWA) FCA Guidance (FCA Guidance).

The FCA Spreadsheet Tool is a downloadable Excel spreadsheet tool that can assist in documenting a financial capability assessment. The FCA Spreadsheet Tool prepopulates data from the Census Bureau and the Bureau of Labor Statistics, provides lists of data sources for additional information need to complete an FCA, and calculates metrics based on the pre-populated and user inputted data.

The training will provide an overview of how the FCA Spreadsheet Tool can used to support evaluation of a community's financial capability to fund CWA control measures in both the permitting and enforcement context. The training will include a live Q&A session. **Details and Registration:** HERE

The Learning Network represents part of a broader technical assistance project, managed by Ecology, to support Washington municipalities in developing and delivering stormwater projects of this kind. <u>Opportunity</u> The Washington State Department of Natural Resources began accepting applications Monday for what is by far the largest amount of urban and community forestry grant funding ever offered by the agency. Applications will be accepted through Jan. 8, 2024, with awards ranging from

\$10,000 to \$350,000 to be announced in the spring. Funds will go to support both single-year projects, as well as those that take multiple years to implement.

Does anyone have examples of Adjustments or Exceptions to the Stormwater Management Manual for Western Washington? We are facing having to make that decision for a development that is proposed in the City of Olympia. The developer is unable to comply with Wetland Hydroperiod Protection for the daily discharge volumes from the site and is seeking an Adjustment from Minimum Requirement #8 Wetlands Protection. If you have any examples or can point me to someone who may have already had to do something like this, that would be great. We've reached out to Ecology, but so far I've only received one example which was an Adjustment to MR #7 in Bonney Lake. Jeremy mentioned the Municipal Permittee Bulletin, would that be a good idea? WORKSHOP/TRAINING/CONFERENCE OPPORTUNITIES:

Stormwater University: Meeting Municipal Surface Water Needs during Intense Redevelopment. The City of Shoreline, Washington is experiencing rapid redevelopment within up zoned residential areas that are served by aging and informal drainage systems. Many redevelopment projects occur on parcels that fall below the size threshold for triggering flow control requirements, resulting in additional impervious area and higher runoff rates during large rain events. Over time, the increased runoff rates may exceed the capacity of the municipal storm system or destabilize the receiving streams. To address

these concerns, the City of Shoreline is taking action to: 1) adopt stormwater permitting policies and flow control requirements that are more stringent than the Washington State standards, 2) perform surface water modeling to evaluate system capacity and identify potential conveyance improvements, 3) explore opportunities for regional detention facilities, and 4) maximize the benefits of green stormwater infrastructure through integrated planning with other City departments. This presentation will describe the contributions of each of these elements and the outcomes of the initial planning studies.
