PEER TO PEER PERMITTEE REQUEST FOR INFORMATION If you have any information to share for the permittee's requests below, please reach out!

A Jurisdiction is asking for information and ideas on how to responds to and support their code enforcement related to Artificial Turf installations in residential areas. A homeowner recently installed 100% of their landscaping with this material, unpermitted. It was installed with a compacted 1.25" minus fill to 2 inches or greater depth. This would imply an impervious surface (although it does not have underdrains). It should be noted that many suppliers *specify* compacted fine granular rock as the

subbase for home installations, which does not correlate to the language developed for artificial turf in the SWMMMWW. As I understand how it is written, all turf and artificial turf is considered pervious unless equipped with underdrains. Have other jurisdictions had similar situations? If so, did they have more diplomatic solutions to address corrective action, other than immediately telling the homeowner to remove a very expensive installation?
